



Assessing the independence and effectiveness of National Regulatory Authorities (NRAs) in the field of energy - Support for a Commission report on Member States' compliance with the principle of independence

Fields marked with * are mandatory.

Introduction

National regulatory authorities ("NRAs") in the energy field exist since the Second Energy Package. However, the regulatory framework at that time suffered from several shortcomings, the first of which concerned independence requirements that were insufficient as there was no obligation for regulators to be independent from governments, but only from energy companies. The effectiveness of regulators was frequently constrained by a lack of independence from governments. This is of particular concern in a sector which is both subject to strong political interest from national governments and in which the biggest market actors and regulated entities are often under state control or with significant shareholdings by public entities.

The Electricity and Gas Directives of the Third Package[1] adopted in 2009 laid down additional rules notably governing the independence of regulatory authorities. Recital 33 of both Directives explains that "the effectiveness of regulation is frequently hampered through a lack of independence of regulators from governments, and insufficient powers and discretion". The 2009 Electricity Directive was recast by Directive (EU) 2019/944 in common rules for the internal market for electricity[2] ("the Electricity Directive").

The principle of independence of national regulatory authorities is enshrined in paragraph 4 of Article 57 of the Electricity Directive and Article 39 of the Gas Directive. The independence requirements do not only

relate to market interests but also to any public or private body, including governments. The Member States' influence on regulatory authorities must be limited to the rights explicitly stipulated in the Directives, such as appointment, approval of the budget or reporting.

The Commission is aware, notably through formal and informal complaints, of obstacles and limitations to these independence provisions in several Member States. These limitations to independence are often hidden in complex inter-linkages between rules and between stakeholders, as well as in informal practices. The rules set out by the legal framework need to be confronted with their impact and effectiveness in real-life situations (i.e., formal vs. real independence). Also, to achieve effective regulation of energy markets, independence of national authorities is a key element, but not in itself sufficient. Other elements, including sufficient financial means and personnel as well as well-functioning internal structures are needed to ensure effective regulatory control.

Against this background, the European Commission (DG Energy) has launched a study to analyse the independence of the NRAs in all Member States, focusing on three broad issues: the independence of NRAs from political and market actors; the adequacy of human and financial resources; and the independence and effectiveness of the NRA in conducting its core tasks.

The study at hand aims at updating the information on 12 NRAs covered by a previous study and at complementing the work for the NRAs of the remaining 15 Member States (i.e. Belgium, Cyprus, Denmark, Estonia, Finland, Ireland, Italy, Latvia, Luxembourg, Malta, Netherlands, Poland, Portugal, Slovenia and Sweden).

The purpose of this survey is to better understand the issues encountered regarding NRA independence in each of the Member States both as regards their independence and their effectiveness in performing their key tasks related to both electricity and gas. All in all, the survey aims to provide insight to support the analysis by gathering stakeholders' opinions on the functioning of NRAs in practice and their (perceived) independence.

Legal and functional independence

The 2009 Gas Directive and the 2019 Electricity Directive both state that the independence of the regulatory authority should be guaranteed. This implies that the NRA should be legally distinct and functionally independent from any other public or private entity and that the NRA and its staff should act independently from market interests. In addition, the NRA should not receive instructions from the government or from market parties, hereby improperly influencing or pressuring the NRA or its staff.
